

ABSTRACT

This study aims to analyse the implementation of the urban village shining program in preventing illicit drug trafficking in Jambi City and analyse the obstacles faced in preventing illicit drug trafficking through the Urban Village Shining Program in preventing illicit drug trafficking in Jambi City. The problem formulations in this study are 1). How is the implementation of the Urban Village Shining Programme on the prevention of illicit drug trafficking in Jambi City? 2). What are the obstacles faced in preventing illicit drug trafficking through the Urban Village Shining Programme in preventing illicit drug trafficking in Jambi City? The research method used in this study is to use the type of empirical legal research by using several data collection techniques such as interviews and observations. Based on the research results show that, The Urban Village Shining Programme carried out by the Jambi City National Narcotics Agency in Legok Urban Village, Jambi City has been implemented as regulated in Presidential Instruction Number 2 of 2020 concerning the National Action Plan for the Prevention and Eradication of Narcotics Abuse and Illicit Trafficking 2020-2024, however, this programme has not been running according to the plan that has been set up. Furthermore, it is known that the obstacles faced are in the form of allocation of funds, facilities and infrastructure, human resources of Jambi City National Narcotics Agency officers, and people who are still afraid to participate in reporting narcotics crimes in their neighbourhood.

ABSTRAK

Penelitian ini bertujuan untuk menganalisis implementasi Program Kelurahan Bersinar terhadap pencegahan peredaran gelap narkotika di Kota Jambi dan menganalisis kendala yang dihadapi dalam pencegahan peredaran gelap narkotika melalui Program Kelurahan Bersinar terhadap pencegahan peredaran gelap narkotika di Kota Jambi. Adapun rumusan masalah dalam penelitian ini yaitu 1). Bagaimana implementasi Program Kelurahan Bersinar terhadap pencegahan peredaran gelap narkotika di Kota Jambi 2). Apa saja kendala yang dihadapi dalam pencegahan peredaran gelap narkotika melalui Program Kelurahan Bersinar terhadap pencegahan peredaran gelap narkotika di Kota Jambi. Metode penelitian yang digunakan dalam skripsi ini adalah menggunakan tipe penilitian hukum empiris dengan menggunakan beberapa teknik pengumpulan data seperti wawancara dan observasi. Berdasarkan hasil penelitian menunjukan bahwa, Program Kelurahan Bersinar yang dilakukan oleh Badan Narkotika Nasional Kota Jambi di Kelurahan Legok Kota Jambi sudah dilaksanakan sebagaimana yang telah diatur didalam Intruksi Presiden Nomor 2 Tahun 2020 Tentang Rencana Aksi Nasional Pencegahan dan Pemberantasan Penyalahgunaan dan Peredaran Gelap Narkotika Tahun 2020-2024, namun program ini belum berjalan sesuai dengan rencana yang telah diatur. Selanjutnya diketahui kendala yang dihadapi berupa dari alokasi dana, sarana dan prasarana, sumber daya manusia petugas Badan Narkotika Nasional Kota Jambi, serta masyarakat yang masih takut untuk ikut serta dalam melaporkan tindak pidana narkotika yang berada dilingkungan sekitarnya.
