Dana desa merupakan satu aspek penting dari sebuah desa untuk menjalankan program-program untuk mengsejahtarkan masyarakat di semua wilayahnya. Pemerintah desa diyakini lebih mampuh melihat prioritas kebutuhan masyarakat dibandingkan pemerintah kabupaten yang secara nyata memiliki ruang lingkup permasalahan yang lebih luas dan rumit. Tujuan dari penelitian ini Mendeskripsikan gambaran pelaksanaan program dana desa Desa Kemingking Luar tahun 2020-2023 dan Mengkaji program dana desa dalam meningkatkan pendapatan usahtani padi sawah di Desa Kemingking Luar. Penelitian ini menggunakan data kuantitatif, cara yang digunakan dalam penelitian ini yaitu: observasi, wawancara, serta dokumentasi. Berdasarkan penelitian ini terdapat kesimpulan, pertama: proses pengelolaan dana desa meliputi persiapan, penganggaran dan pelaksanaan. Penggunaan dana desa yang dilakukan oleh pemerintah Desa Kemingking Luar Kecamatan Taman Rajo telah mengikuti aturan petunjuk teknis yang telah diatur dalam perundang-undangan.

ABSTRACT

Village funds are an important aspect of a village to carry out programs to improve the welfare of the community in all its areas. It is believed that the village government is more able to see the priority needs of the community than the district government which actually has a wider and more complex scope of problems. The aim of this research is to describe the implementation of the village fund program in Kemingking Luar Village in 2020-2023 and examine the village fund program in increasing income from rice farming in Kemingking Luar Village. This research uses quantitative data, the methods used in this research are: observation, interviews, and documentation. Based on this research, there are conclusions, first: the village fund management process includes preparation, budgeting and implementation. The use of village funds carried out by the government of Kemingking Luar Village, Taman Rajo District, has followed the technical guidance rules that have been regulated in legislation. However, the process is still not optimal. Second, factors that influence village fund management include supporting factors and inhibiting factors. Supporting factors are community participation, facilities and infrastructure.
