CHAPTER I

INTRODUCTION

1.1 Research Background

Various reform efforts have been carried out by the government in order to improve the quality of education, one of which is through improving the existing curriculum. A curriculum also refer to a document that contains formulations about objectives, teaching materials, and teaching and learning activities. So, the curriculum has coverage broad, because it includes all student activities, student experience, and all influences, both physical and non-physical on the growth and development of students. So, it is very important for a teacher to know the students' perceptions of the material. By considering students' perceptions of teaching materials used, the teacher becomes easier to teach.

Textbook are one of the teaching materials in printed form that are used by students as a tool for independent learning and are used by a teacher to provide material to students. Learning of *Pengelolaan Pendidikan* courses in English education study program at FKIP Jambi University uses a textbook teaching material that has been prepared by lecturer. So, in this study the researcher want to describe how the EFL students' perception toward "Pengelolaan Pendidikan" textbook for English students at FKIP Jambi University.
